The attached forms are required for "post-construction" improvement approval. The forms must be filled out in their entirety prior to review. Improvements shall be considered for the purpose of pools, fences, docks, patios, storage buildings, permanent basketball units, sunshades, gazebos, trellises, or any other structure of significant size or permanent ability.

Each Improvement Review must be accompanied by Improvement Review Deposit made payable to Doubletree HOA. This fully-refundable deposit shall be held by the HOA until completion of the improvement plan submitted and provision of the Declaration of Covenants. Deposit will be refunded, minus incidentals paid by the Developer or HOA, when improvement is complete, inspected, and deemed satisfactory by the Architectural Review Committee (ARC). In addition, a non-refundable Architectural Review fee must also be submitted in a separate check made payable to Doubletree HOA.

Every effort will be made to review your completed and submitted Improvement Approval Request Form as quickly as possible. Please allow approximately 10 days for completion.

Improvement construction is not to begin prior to receiving a written approval of at least three (3) Architectural Review Committee members.

The refundable deposit amount may be adjusted by ARC as necessary.

All work shall comply with the Town of Winfield's requirements.

Improvement completion must not exceed 120 days without express written approval of the Architectural Review Committee.

Improvement approval shall be contingent on the requirements hereto as well as the Architectural Review Committee's determination that the improvement plans meet or exceed the architectural and aesthetic appearance of the development.

The Improvement Review Deposit shall be refunded, minus incidentals paid by the developer or HOA, when required improvements are completed, inspected, and deemed satisfactory by the Developer and ARC.

The Improvement Review Fee is non-refundable.

Note: Most construction activities are not permitted between the hours of sunset and 7am Monday-Saturday and are not permitted on Sundays.

The following must be completed in its entirety and be accompanied by a set of complete PDF plans and survey (if necessary) prior to submittal to Architectural Review Committee. It is recommended that your submission package include pictures, brochures, color selections, dimensions, etc.
